SikaBlock® M935 is designed for foundry models, match plates and core boxes (cold box process). It is as well suited for various molds and tools, e.g. for true-to-size gauges and for master models, where a high surface quality and superior strength is required. METHOD OF APPLICATION

Product preparation

Before SikaBlock® M935 boards can be processed (machined) they must be conditioned to $18 \, ^{\circ}\text{C} - 25 \, ^{\circ}\text{C}$.

If the boards need to be bonded, make sure that the surfaces are clean, dry and free of grease or oil. For cleaning Sika® Cleaner G+M or another suitable cleaner or solvent can be used.

For bonding SikaBlock® M935 boards together use SikaBiresin® B180. Further details on the adhesives can be found in the respective Product Data Sheet.

Application

SikaBlock® M935 can be easily machined by milling, drilling, sawing or modified manually. It is recommended to use high performance tools to machine these boards.

For milling parameters check information from cutting tool manufacturers or get the General Guideline "Milling parameters for SikaBlock®" for more general information.

STORAGE CONDITIONS

The board needs to be stored flat over the entire surface in dry conditions.

Many models and tools are made of bonded boards, either with identical or other materials. Storage at low and elevated temperature can lead to high stresses due to the different expansion coefficients. To prevent this, it is necessary to store the models and tools at a temperature range between 15 °C and 30 °C.
