DESCRIPTION

SikaGlaze IG-5 PIB-2 is a 1-component, solventfree, thermoplastic primary seal for dual-seal insulating glass units based on polyisobutylene (PIB, butyl).

PRODUCT BENEFITS

- Low water vapor transmission and argon permeation
- Good adhesion to most glass and spacer materials
- Excellent UV resistance
- No shrinkage
- Thermal conductivity = 0.2 W/m K (EN 10077-2)

AREAS OF APPLICATION

SikaGlaze IG-5 PIB-2 is used as primary seal in the production of dual-seal insulating glass units. It has been tested against EN 1279-4. This product is suitable for experienced professional users only. Test with actual substrates and conditions have to be performed to ensure adhesion and material compatibility.

CURE MECHANISM

SikaGlaze IG-5 PIB-2 is a non-reactive polyisobutylene and stays paste-like and viscoelastic.

METHOD OF APPLICATION

Surfaces must be clean, dry and free from grease, oil and dust.

Surface preparation

SikaGlaze IG-5 PIB-2 must be heated-up to the required application temperature before being applied by the extruder. Preliminary application tests to set up the equipment are mandatory.

Removal

SikaGlaze IG-5 PIB-2 may be removed from tools and equipment with Sika® Remover-208 or another suitable solvent.

Hands and exposed skin have to be washed immediately using hand wipes such as Sika® Cleaner-350H or a suitable industrial hand cleaner and water.

Do not use solvents on skin.

Application limits

Recommended solution from Sika for insulating glass production are usually compatible to each other. These solutions consist of products such as Sikasil® SG, IG, WS and WT series. For specific information regarding compatibility between SikaGlaze IG-5 PIB-2 and other Sika products contact the Technical Department of Sika Industry.

To exclude materials influencing SikaGlaze IG-5 PIB-2, all materials such as gaskets, tapes, setting blocks, sealants, etc., in direct and indirect contact have to be approved by Sika in advance.
